4.1. Description of necessary first-aid measures

First-aid measures general	: First aider: Pay attention to self-protection. Never give anything by mouth to an unconscious person. Give artificial respiration if necessary. Induce artificial respiration with mask fitted with one-way valve or other suitable device but, not mouth-to-mouth. Call a poison center/doctor/physician if you feel unwell.

If the victim is unconscious: Lay in a stable manner on victim's side. Induce artificial respiration with mask fitted with one-way valve or other suitable device; not mouth-to-mouth. If experiencing respiratory symptoms: Call a poison center or a doctor.
First-aid measures after skin contact	: Remove affected clothing and wash all exposed skin areas with mild soap and water, followed by warm water rinse. If skin irritation occurs: Get medical advice/attention. Wash contaminated clothing before reuse.
First-aid measures after eye contact	: IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.
First-aid measures after ingestion	: Rinse mouth. Do NOT induce vomiting. Give a slurry of activated charcoal in water to drink. Never give anything by mouth to an unconscious person. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Call a physician immediately.
